Legislation Update

Recommendation to Co-Sponsor Legislation with SSCCC

Wendy Brill-Wynkoop

Wendy gave an update on two bills – AB 2707 (Fong) student study housing bill and AB 2370 (Cervantes) assert instructors should be human. Both bills should be heard in April.

CTA is co-sponsoring a bill on limiting district reserves. CCCI does not have any specific bills. CFT sponsoring 75/25 rule, part-time office hours, and limiting district reserve funds.

SSCCC sponsored bill AB 2303 (Reyes) community colleges: EBT (electronic benefits transfer) cards.

It was suggested to present these concerns and approve conditionally with qualification to ensure they are addressed in the language.
