Legislation Stephanie Goldman

Stephanie noted the list of bills supported by the board.

- AB 1232 (McCarty) – ESL

- AB 1746 (Medina) Cal Grant Reform
- AB 1856 (Medina) Part-Time faculty 80-85%
  - a. Cosponsorship requested by author's office
- AB 1752 (Santiago) Part-Time Parity
- AJR 26 (Medina) Student loan debt repayment
- AB 1764 (Medina) Student Housing Survey
- AB 1712 (Medina) Campus climate sexual misconduct survey
- AB 1187 (Irwin) Tutoring appropriation

The following bills are being recommended for a position of support.

SB 868 – SBMA Option 1. The bill has been reviewed by the legislative and policy committees.

AB 2820 (Medina) – would eliminate Calbright College. The legislative committee has not had a chance to review this bill yet. Medina's office has reached out to request we sign on as cosponsors.

Evan noted that we are being asked to cosponsor some of these bills. There may be some bills that may come up between now and the next board meeting. It was suggested that the executive committee make decisions between meetings. If there is anything contentious, it will be brought to the board.

- Gann limit if the budget goes over a certain amount restrictions could be implemented. The governor has not addressed this yet.
