AB 2315 (Arambula)

Evan Low came on as a cosponsor. Bill is heading to the appropriations committee. This bill may not go to appropriations as there is little cost.

AB 2232 (McCarty)

This bill would make sure all facilities have heating, ventilation and air conditioning.

SR 45 sponsored legislation on academic freedom. Did not pass the Senate.

85% load bill AB 1505 is sitting in Senate Rules.

AB 1856 made out of Assembly, it is going to appropriation.

Most bills will go to the suspense file and decide which ones will pass and which ones won't. It is the easiest way to kill a bill.

Calbright made it out and will go to appropriations.

AB 1705 (Irwin)

FACCC continues to oppose this bill. It passed the Assembly and now moves to the Senate.

State Budget Update

Evan noted that \$200 million was proposed for part-time healthcare in January. Most exciting news is that the Senate released their budget priorities – advocating \$700 million in base funding. Additional funding for MESA and EOPS. \$30 million to help native American students. There is a lot of one time money (\$1 billion) for student housing.

Brill-Wynkoop called for a short 10 minute break.
