Budget Update

Wendy noted revenues continue to be uncertain. Heavy storms at the beginning of the year pushed the tax filing period to October 2023. This will delay funds coming into the state. Both the Governor and Legislature are bracing for an even larger deficit than anticipated. Despite the bleak outlook they want to look towards supporting education. COLA could be higher than anticipated. However, COLA eats into other programs for community colleges and might not be approved. The Legislature is starting hearings on the community college budget.

Statement Denouncing HB 999

Wendy gave kudos to the policy committee for the quick turnaround paper on HB 999. It attacks academic freedom, tenure, shared governance as well as being sexist and racist. The document will go back to the policy committee for editing purposes and will be brought back at May meeting.
