--External Liaison Reports

EOPSA Efren Rangel

Northern California Ambassador

Dolores Davison

Dolores has worked with Hartnell College and they have an interest in working with us. Talked with Coast College and they may be interested in an FACCC institutional partnership. Attended BOT meeting at Ohlone on behalf of FACCC. Trial contract membership was voted and agreed at Ohlone. Interesting conversations about the politics of rural colleges.

Southern California Ambassador

Emily Haraldson

Discussed has met with S. Orange Co. FA about trial membership. Planning FACCC events at LACCCD. Tabling at LB City college. Planning event at Cerritos.

Working on membership appreciation drive. Sending out lists to board members to provide lists of faculty members to send appreciation notes. FACCC will provide script and notes.

--FACCC Think Tank

Sarah Thompson

Sarah reported on the JLAC audit. Archuleta will be the author of the bill. Talking points for the A&P visit have been finalized and printed. For budget advocacy, FACCC is focusing on eliminating the COLA penalty. She presented a revised Excel sheet of SCFF "winners and losers." Challenge of the "hold harmless" language sigmatism. Could we ask to "apply COLA to the funding floor"?

Shared a comparative document on the funding of different higher education institutions. It highlights many of the interesting details that distinguish between funding models. Demonstrate the underfunding of the CCC system.

Previewed the "per-district funding" document that is in progress. A significant disparity exists between districts in per-district funding.

Trailer bill to eliminate COLA penalty is being considered. Considering a JLAC audit on fraudulent students.

Using TT budget to encourage faculty to travel to Sacramento for advocacy. Previewed Student Agency and Access with a brief update. Need great number of small group studies.

Recently met with the UC BOARS commission. UCs don't seem to be willing to change admission standards; they must have Algebra II. It might be a campaign idea to amend AB 1705.

--Social Security Fairness Act

Sharon Hendricks/Jessica Saint Paul (STRS)

Sharon and Jessica presented details of retirement and the signing of HR82. Briefly described WEP/GPO and how HR82 changes the game. Provided a comparison chart for various STRS plans and how the decision-making process is very individualized. Can share the one-page chart.

--Legislative Update

Anna Mathews

Reported about AI bill for Counseling and Library faculty and the JLAC audit on SCFF. SB241 Cervantes seems likely to succeed. Initial conversation of PT healthcare state-wide pool for un-bargained districts system advocacy request; maybe Patel's office is interested.

Hundreds of folks showed up to support the fight against AB1705 at the oversight committee hearing. Please watch the public comment. Assemblymember Irwin is not willing to allow for changes to her legacy legislation AB1705. Without a current bill, how can we maintain the momentum?

--FACCC's DEI Goals

Jacob Traugott

Jacob reported on the efforts to synthesize the meeting notes from the Board's discussion of DEI efforts. They expanded the document and grouped items. Recommended changing the title to DEIA. Recommended adding BIPOC students and students with disabilities.

The section regarding complaints and concerns was discussed and will be further addressed by Oranit. We need to have a process in addition to a form for receiving concerns and complaints.
