- AB 14 - Public Broadband Services
  - Recommended support
- AB 106 (Salas) – Establish Regions Rise Grant Program (no details)

1. **Bring back on 3/8/21**

- AB 275 (Medina) – Classified staff at CCCs
  - Shortens probation period for classified
  - **Why is this a bill? Benefits of shortening this?**
- AB 299 (Villapudua) – Apprenticeship program
  - **Funding source?**
- AB 316 (Cooper) – Pay equity for minority groups at the state
  - **Spot bill - Watch**
- AB339 (Lee) – Open meetings - virtual clarification
  - Cost concerns: All of these Brown Act meetings require real-time closed captioning, an interpreter

2. Committee Recommendation: Support, but amend

1. Needs ADA compliance and cost support

- AB 367 (Garcia) – Require CCC, CSU, and UC, plus other public agencies, to stock 50% of all campus restrooms with free menstrual products at all times.
