# • Ed Code Changed in Mission via budget process

- AB 2973, Omnibus bill, was approved by the governor in September 2022. It removed the
  provision of remedial education for those that need it in EDC §66010.4 CCC Mission.
- Announced change to the CCC mission done through budget omnibus bill. Concerns for transparency. Will bring this back to committee in May.
