[AB 1930 \(Medina\)](#) - Would require the Trustees of the California State University, and request the Regents of the University of California, before making any change in undergraduate student eligibility policy that adds eligibility requirements that impact students across its segment, to engage in discussions with and coordinate with other educational segments that will be impacted by the policy in order to understand the impacts of the policy and try to align their respective student eligibility policies.

 - f. [AB 2282 \(McCarty\)](#) – Requires the CCCs, UCs, and CSUs establish a CalFresh student outreach program to provide students with a link to an internet website with information on applying for CalFresh benefits and to provide students with the name

and telephone number of the CalFresh eligibility worker on their respective campus, if one is available.

i. Recommend: Support

- g. [AB 2972 \(Limon\)](#) – Would create system-wide training programs at the CCC, CSU, and UC, for administrators, faculty, and staff, of those respective segments to complete annually, relating to undocumented students, Deferred Action for Childhood Arrivals (DACA), federal and state laws related to immigration generally, state law relating to exemption from nonresident tuition, and resources that the system or campus has for undocumented students.
