- **Policy Committee** White Paper Update: Deirdre & Cynthia
- **Review 5 Step Process:** Steps for FACCC to officially endorse the One Tier System policy proposal:
 1. Policy Committee needs to create a policy position (White Paper) to submit to the Executive Committee **working with the PT committee.**
 2. The Executive Committee will review the white paper and decide whether or not to pass it to the Board of Governors.
 3. If passed, the Board of Governors will vote to decline or accept the policy as an official FACCC position. **The Board could also send it back to the committee for more details.**
 4. If approved the Legislative Committee **could** package it for the 2024 legislative session. Note: **This is a separate process, so we can't promise it will occur in the 2024 legislative year (however it can be the goal). Even if the legislative committee has it in its package, it needs to also be approved by the board.**
 5. Generally speaking, we begin looking for authors for the bill in Nov. Deadline to introduce a bill is in Feb
