### **Policy Forum: Immigration Policy and California Community Colleges (Jan. 31, 2026)**

Federal and state immigration policies impact faculty, staff, and students within the California community college system. Colleges continue to advance accessibility and support for those impacted who, in turn, contribute to diverse learning communities. State officials and faculty leaders who also faced difficulties can provide crucial guidance to navigate changes and

continuities in the immigrant experience. Legal counsel has similarly shepherded courses of action taken by faculty, staff, and students across collegiate California. The 2026 Policy Forum aims to coalesce these experiences, that guidance, those dreams, and sustained leadership roles into a forum for strategies and ideas that will help fulfill the goals of immigrants and allies alike.

### **Policy Paper Proposals**
