 - a. Part-Time Faculty Issues
 - i. High priority for FACCC board
 - 1. *A path of tenure for ALL faculty!
 - 2. ONE FACULTY single tier faculty
 - a. (Greg Gilbert's "Why Faculty Matter" Regrouping under one faculty working towards equity.
