RECENT LEGISLATIVE ACCOMPLISHMENTS

2019	AB 705 (Low) - Eliminated the 3-year time limit for transferring sick leave between districts.
2019	AB 595 (Medina) -Allows undocumented students to use an Individual Taxpayer Identification Number (ITIN) in lieu of a social security number when enrolling in career education programs with a background check component.
2020	AB 2884 (Berman) - Allows districts to use restricted lottery funds for student basic needs.
2021	AB 1326 (Arambula) - Requires county human services agencies to designate a staff liaison as a point of contact for higher education counselors.
2022	AB 2315 (Arambula) - Requires CCCs to allow students, faculty, and staff to use their chosen names on all non-legal documents and programs.

LEGISLATION

- Prevent cuts to community college funding.
- Defend categorical programs from proposals to open up their funding.
- Support reforming the student centered funding formula and advocating for more base funding, data collection, and eliminating performance-based funding.
- Advocate for funding to support students in transfer-level courses, including embedded tutoring.
- Support reforms to the Cal Grant that will benefit community college students.
- Oppose continued Calbright funding.

- Ensure the responsible and ethical use of AI within the classroom while safeguarding the interests of students and maintaining the integrity of the educational experience.
- Support programs and resources tailored to older-unhoused students within the California Community College system.

FEDERAL ADVOCACY

- Support DACA recipients.
- Eliminate the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) in the Social Security Act.
- Support funding for Pell Grants and other financial aid.

PROFESSIONAL DEVELOPMENT
